



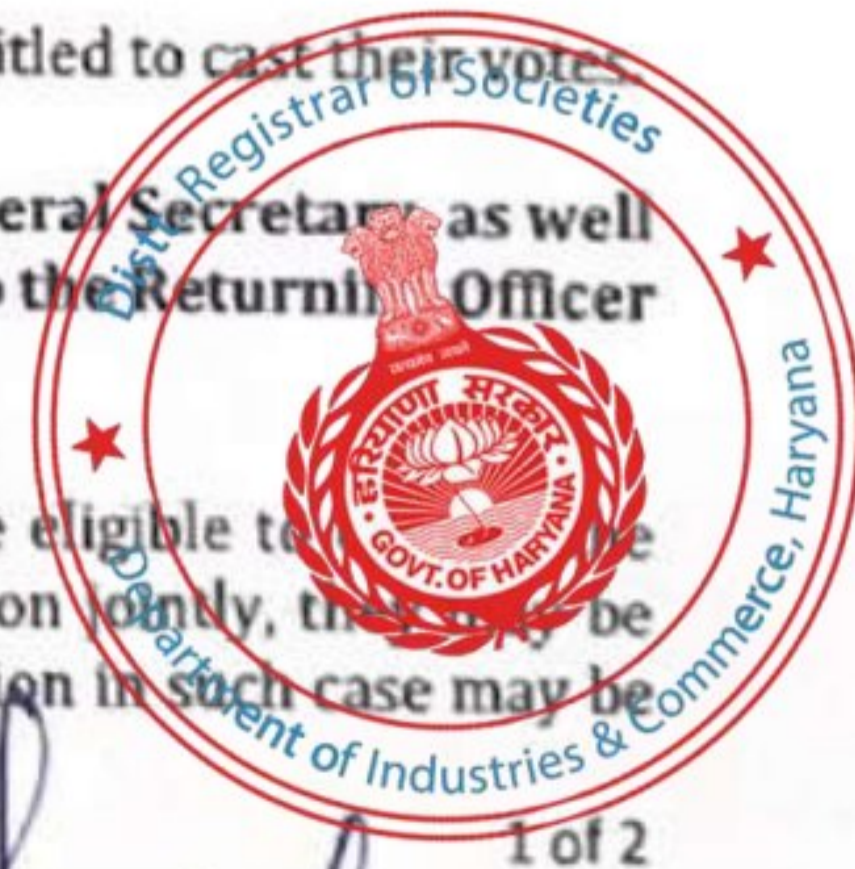

1. The election will be held for the post of President, Vice President, General Secretary, Joint Secretary, Treasurer & Executive Member (04) as per HRRS ACT 2012 and By-laws.
2. As per HRRS ACT 2012 29 every member shall be eligible to cast their vote in person.
3. As per HRSS ACT 2012 firm barred from being members, so the firms are not entitled to cast their votes.
4. **Nomination form will be circulated by Ex governing body by President/General Secretary as well pasted on the notice board and duly filed form will handed over in person to the Returning Officer on scheduled day.**
5. **Joint Apartment Owners:** In case of joint apartment owner, 1st owner will be eligible to cast their votes in elections. When an apartment has been allotted in favour of two or more person only, the person will be jointly entitled to the ownership of their allotment and the share of the association in such case may be

issued in their joint name. However, the person whose name stands first in the allotment letter shall have the right to vote. First owner can transfer their voting right to second owner via an authority letter with proof of ownership in the allotment letter as second owner.

6. Every eligible member is entitled to cast one (1) votes to the posts, one each to the
 - 1). President
 - 2). Vice President
 - 3). General Secretary
 - 4). Joint Secretary
 - 5). Treasurer
 - 6). Executive Member(04)
7. Every member who wants to contest the election, he shall submit his nomination in person to the R.O. He should enclose copy of allotment letter. The candidates who seek election shall mention the post for which he/she are seeking election as per posts listed in serial no, I above mentioned in the nomination form. Persons shall propose and second the candidates.
8. Polling Date may be deferred or amended considering COVID – 19 pandemic situations in the society or as per restrictions and directives from the administration. Strict Self Distancing Norms and Due Diligence including Face Covers are mandatory for the society members and staff involved in election activity during the entire process.
9. Every Member is requested to show their identity card at the time of voting (Aadhar Card/Identity Card of Association).
